State-issued documents for use in countries that are members of 1961 Hague Convention must be authenticated by the competent authority in the state where the document was executed.. A state-issued document with an apostille does not require additional certification by the U.S. Department of State or legalization by a U.S. embassy or consulate overseas to be recognized in a participating country.

Electronic/Remote Notarization Electronic notarization and remote notarization are not the same thing. Electronic notarization (eNotarization) involves documents that are notarized in electronic form. The notary and customer both sign with an electronic signature, and both the notarial certificate and the notary seal are attached to or logically associated with the electronic record.

Title 26, Chapter 1 of S.C. Code of Laws defines the duties and acts performed by notaries public in the state of South Carolina. The Secretary of State commissions notaries public for South Carolina and keeps their oaths of office on file.
