16 Hour On-The-Job Training (OJT) - A course relevant to the duties of guards, requirements of the work site, and the needs of the employer. You must complete this training within 90 days of employment as a security guard.

NYS Division of Licensing Services

All security guards are required to complete an 8 Hour Pre-Assignment Training Course prior to applying to the Department of State for a Security Guard Registration Card. That course must be followed by a 16-Hour On-the-Job Training Course for Security Guards within 90 days of initial employment as a security guard.

Security Guard Training - NY DCJS

Training for security guards was mandated by the Security Guard Act of 1992. The Act requires that all security guards complete three training courses. Armed guards are required to complete two additional training courses. All courses must be conducted at
